#### **MOTORING & LEISURE SERVICES LTD**

#### TERMS OF REFERENCE OF: THE MLS BOARD OF DIRECTORS

#### Definitions

1. In this document:

"Articles"	means the Articles of Association of MLS
"the CSMA"	means the Civil Service Motoring Association Ltd
"the CSMA Board"	means the Board of Directors of the CSMA
"MLS"	means Motoring & Leisure Services Ltd
"the MLS Board"	means the Board of Directors of MLS

#### **General and Specific Responsibilities**

- 2. The MLS Board is collectively responsible for the long-term success of MLS and ensuring that it is run in the best interests of its member (i.e. its holding company, the CSMA). The MLS Board:
  - (a) sets the strategy for MLS and approves strategic, capital and operating plans presented by management for the achievement of the strategic objectives it has set.
  - (b) monitors and oversees MLS's operations, ensuring competent and prudent management, sound planning, proper procedures and systems of internal control and compliance with statutory and regulatory obligations.
- 3. In addition, the MLS Board has the specific responsibilities set out in **Appendix 1** to these Terms of Reference.

## Powers of the MLS Board

- 4. In managing MLS, the MLS Board may exercise all the powers of MLS, subject to:
  - (a) These Terms of Reference (including paragraph 5 below, 'Reserved Matters')
  - (b) any applicable legal or regulatory requirements; and
  - (c) the Articles.

## **Reserved Matters**

- 5. To the extent permitted by any applicable legal or regulatory requirements:
  - (a) The matters set out in **Appendix 2** to these Terms of Reference require express approval of the MLS Board.

(b) The matters set out in **Appendix 3** to these Terms of Reference require prior consultation with or approval by the CSMA Board.

# **Companies Act Duty**

- 6. Section 172 of the Companies Act 2006 requires each member of the MLS Board to act in the way they consider, in good faith, would be most likely to promote the success of MLS for the benefit of its members as a whole (i.e. its holding company, the CSMA), and in doing so to have regard (amongst other matters) to:
  - (a) the likely consequences of any decision in the long term,
  - (b) the interests of MLS's employees,
  - (c) the need to foster MLS's business relationships with suppliers, customers and others,
  - (d) the impact of MLS's operations on the community and the environment; and
  - (e) the desirability of MLS maintaining a reputation for high standards of business conduct.

# Delegation

- 7. Subject to **paragraph 5** above ('Reserved Matters') and to the extent permitted by any applicable legal or regulatory requirements:
  - (a) The MLS Board may delegate and confer on any director or other person any of its powers, authorities and discretions (including the power to sub-delegate) for such time and on such terms as it thinks fit.
  - (b) In particular, the MLS Board may delegate any of its powers, authorities and discretions for such time and on such terms as it thinks fit to any Committee of the MLS Board that consists of two or more of MLS's directors.

## Composition of the MLS Board

8. The composition of the MLS Board and the appointment and removal of directors is governed by the Articles.

## **Board Meetings**

- 9. Proceedings of the MLS Board of Directors are governed by the Articles.
- 10. The MLS Board shall meet sufficiently regularly to discharge its duties effectively. It is expected that the MLS Board shall normally meet at least four times a year.
- 11. Minutes of the MLS Board shall be minuted, including recording the names of those present and in attendance. The minutes shall be circulated to all members of the MLS Board unless exceptionally it would be inappropriate to do so (for example, when matters personal to an individual director were discussed).

12. Individuals who are not directors of MLS may be invited to attend and speak at meetings of the MLS Board or at meetings of any committee of the MLS Board on a regular or ad hoc basis. However, they shall not be entitled to vote on any resolution put to the MLS Board or relevant committee.

# **APPENDIX 1**

### SOME SPECIFIC RESPONSIBILITIES OF THE MLS BOARD

### MLS strategy and management

- 1. To formulate and approve MLS's long term objectives and strategy.
- 2. To monitor the performance of MLS's business against plans, budgets and forecasts.
- 3. To approve extension of MLS's activities into new business.

## Compliance

- 4. To ensure regulatory and legal compliance by MLS.
- 5. To act consistently within the rules and principles of the Financial Conduct Authority in respect of MLS.

# **Financial matters and internal controls**

- 6. To oversee MLS's operations and ensure competent and prudent management, sound planning, an adequate system of internal control and adequate accounting and other records.
- 7. To approve MLS's annual budgets, strategic and business plans.
- 8. To review and approve MLS's financing, banking and treasury policies.
- 9. To ensure maintenance of a sound system of internal control and risk management.
- 10. To approve MLS's Annual Report and Accounts.
- 11. To monitor the performance of MLS businesses against plan and budget.
- 12. To approve any significant change in MLS's accounting policies.

# Other

- 13. To approve MLS's Board Minutes.
- 14. To consider any other matters put to the MLS Board by any director of MLS or the Company Secretary.

# APPENDIX 2

# MATTERS REQUIRING EXPRESS APPROVAL BY THE MLS BOARD

- 1. MLS's strategy and any changes to it.
- 2. MLS's annual budget and changes to it.
- 3. An item of capital expenditure involving cost to MLS of £100,000 or more.
- 4. MLS entering into a contract with a value of £100,000 or more.
- MLS commencing or settling any material legal proceedings. For these purposes legal proceedings or a dispute shall be deemed to be "material" if it involves a claim of £100,000 or more by or against MLS.

# **APPENDIX 3**

# MATTERS REQUIRING PRIOR CONSULTATION WITH OR APPROVAL BY THE CSMA BOARD

# Prior Consultation with the CSMA Board

- 1. The appointment by the MLS Board of any person as a director of MLS.<sup>1</sup>
- 2. An item of capital expenditure involving cost to MLS of £250,000 or more.
- 3. MLS acquiring or disposing of an asset having a value of £250,000 or more.
- 4. MLS entering into a contract with a value of £250,000 or more.
- 5. MLS commencing or settling any major legal proceedings. For these purposes legal proceedings or a dispute shall be deemed to be "major" if it involves a claim of £250,000 or more by or against MLS.
- 6. MLS making any loan or granting any credit or giving any guarantee or indemnity (other than in the normal course of trading e.g. employee season ticket loans).
- 7. MLS significantly changing the nature of its business or commencing any new business which is not ancillary or incidental to its existing business.

# Prior Approval by the CSMA Board

- 8. MLS forming any subsidiary.
- 9. The issue of any shares by MLS to any person other than CSMA.
- 10. MLS amalgamating or merging its business with any other company or business undertaking.
- 11. MLS creating any charge or other security over the whole or any part of its business, undertaking or assets (other than liens arising in the ordinary course of business or any charge arising by the operation or purported operation of title retention clauses and in the ordinary course of business).
- 12. Changing the auditors of MLS or its financial year end.
- 13. Any material change in the accounting policies and principles adopted by MLS in the preparation of its audited accounts (except as may be required to ensure compliance with relevant accounting standards under the Companies Act 2006 or any other generally accepted accounting principles in the United Kingdom).
- 14. Any changes to these Terms of Reference.

<sup>&</sup>lt;sup>1</sup> Article 13 of MLS's Articles of Association give the MLS Board the power to appoint a person as a director (either to fill a vacancy or as an additional director).
