*Terms and conditions apply.

The two months discount on Private Medical Insurance and 50% discount on a 12 month PureGym membership (the **"Offer"**) is available to Eligible Customers only and is available upon the purchase of an Eligible Plan. Eligible Customers may only use this Offer once. This Offer is non-transferrable and cannot be substituted for a cash alternative.

The promoter of this Offer is AXA PPP healthcare Group Limited (registered number 03148346), whose registered office is at 5 Old Broad Street, London, EC2N 1AD (**"we"** or **"us"**). We are the service company to AXA PPP healthcare Limited (**"AXA PPP"**), and are both part of the AXA Group.

"Eligible Plan" means a Personal Health or Health for You policy or any other private medical insurance policy as agreed between the Parties in writing from time to time.

"Health Assessment" means one free lifestyle health assessment carried out at one of 42 Nuffield Health Facilities across the UK. The 50% discount on a 12 month PureGym membership (the **"Discount"**) and the Health Assessment are redeemable through the Active+ website. You will be sent an email to the email address you provided to AXA PPP on the purchase of your Eligible Plan within 28 days of AXA PPP receiving your first premium payment, or if you choose to pay annually, within 28 days of receiving your first annual payment, provided you have not cancelled your plan (the **"Redemption Email"**). The Redemption Email will contain two promotional codes and information regarding redemption using the promotional codes on the Active+ website. For the avoidance of doubt, if you fail to comply with these terms and conditions, you will not be entitled to receive the Redemption Email.

Two months free Private Medical Insurance

If paying annually, you will only be charged for 10 months of Private Medical Insurance cover. If paying monthly, the 11th and 12th month of cover will be free and you will not be charged in these months. The Offer applies to the first year of your Eligible Plan only. At the renewal of your Eligible Plan and at all future renewals, your premium will be calculated on a 12 month basis in the normal way.

The Health Assessment:

Only one Health Assessment is available per Eligible Plan. In the event that family members are included on an Eligible Plan, the lead member may nominate another family member on the Eligible Plan to take the Health Assessment in their place.

The Health Assessment does not affect any of your standard terms and conditions that apply as part of your Eligible Plan and will not affect your premium or any no claims discount that you may have. Should you require subsequent tests or treatment as a result of your Health Assessment, cover will be subject to the usual eligibility criteria of your Eligible Plan.

A cancellation policy applies to Health Assessments booked but not taken up – full details provided upon booking.

General:

This Offer cannot be used in conjunction with any other offers, apart from our 5% discount for paying annually. This Offer may be withdrawn at any time. If any of these clauses should be determined to be illegal, invalid or otherwise unenforceable then it shall be severed and deleted from these terms and conditions and the remaining clauses shall survive and remain in full force and effect.
